GQR Johns Hopkins Center for a Livable Future: Maryland Food Citizen Poll June 2022

Methodology

On behalf of the Johns Hopkins Center for a Livable Future (CLF) as part of its Food Citizen Project, GQR conducted a Maryland statewide phone survey of 604 registered voters (500 weighted) plus 152 registered voters (40 weighted) in the Eastern Shore. The survey was conducted in late June 2022, and respondents were contacted through the voter file.

The data is subject to a margin of error of +/-3.99 percentage points (+/- 7.95 Eastern Shore OS) at the 95 percent confidence interval and the margin of error is higher among subgroups.

The data are statistically weighted to ensure the sample's regional, age, and gender composition reflects that of the estimated registered voter population in Maryland.

In this report, results are expressed as percentages unless otherwise noted. Results may not add to 100% due to rounding or multiple responses. Net results cited in the text may not exactly match individual results shown in the charts due to rounding.



Government Role and Environment



Voters want the government to do more

More favorable to big chicken processing companies

Sentiments around Poultry Farms



Voters less familiar with poultry farming, but view them as important for economy

How familiar are you with industrial chicken farming, or farming that produces very large quantities of poultry for commercial sale, in Maryland?

From what you know or have heard, how important is industrial chicken farming and the poultry industry to the Maryland economy?



Overwhelming support of integrators sharing liability with growers

Most farms in Maryland that raise chickens' contract with larger companies like Perdue and Tyson. In these contracts, the companies, known as integrators, own the chickens. They supply growers with chicks and feed, then return to claim the birds for slaughter. The growers, or small farmers own the waste and dead birds, and they are legally responsible when they are not handled properly. Do you support or oppose the idea that integrators should share liability with the growers for disposing waste?



Overwhelming support for monitoring and enforcement of Clean Water Act on CAFOs

The Clean Water Act requires Concentrated Animal Feeding Operations, or CAFOs to obtain a National Pollutant Discharge Elimination System (NPDES) permit before they are allowed to discharge pollutants into water bodies. Do you support or oppose the monitoring and enforcement of the Clean Water Act on Concentrated Animal Feeding Operations, or CAFOs?



- Partisanship: Broad support across the board, with Democrats at a higher intensity of support (93 percent) vs. Republicans (86 percent).
- Region: Broad support, but Eastern shore has lowest amount of intensity of support (56 percent).
- Age: Broad support, differences within MOE.
- Education/Gender: Higher intensity of support among college men and college women.



Majority favor implementing tougher environmental standards even on CAFOS with fewer birds

CAFOs with fewer than 37,500 birds do not need to receive a permit before they are allowed to discharge pollutants into bodies of water. Do you favor or oppose implementing tougher environmental impact standards that apply to all CAFOs, including ones that are smaller in size?



- Partisanship: Republicans show high support, but popularity driven by Democrats and independents.
 - Region: Strongest support in the Prince George's/Montgomery county (85 percent favor).
- Age: Support driven by younger voters (82 percent support), compared to older voters (75 percent).
- Education/Gender: College educated voters have higher level of support (83 percent) than non-college (74 percent). Driven by college men (82 percent).



Majority support an increase in oversight to industrial chicken farming industries



Strong support for proposals overseeing the chicken farming industry

Now here are some specific proposals related to the industrial chicken farming industry. For each, please indicate whether you support or oppose that proposal.



(Split) Require large poultry processing companies to pay for the removal of chicken waste from their local contract growers.

(Split) Encourage local counties and communities to pass public health laws that limit the construction of new poultry houses and the number of animals that can be contained in one area.

Allow local communities to place limits on the overall number of chickens that can be contained in one area, whether in an individual operation or across multiple properties.

(Split) Establish a 5-cent per chicken fee on poultry processing companies that would be dedicated to protecting Maryland waterways, land, and air from negative impacts of chicken waste.

(Split) Place a limit on the construction of new and expanded industrial chicken farm production facilities.

Nearly half say gubernatorial candidates support to increase oversight makes them more favorable

Pesticides and Plant-Based Foods



Strong support for a moving away from factory farmed animal products and towards lower-carbon, plant-based foods in state food procurement

Do you (SUPPORT/OPPOSE) Maryland shifting the state's food procurement away from factory farmed animal products toward lower-carbon, plant-based food in alignment with greenhouse gas reduction targets?



• Partisanship: Democrats support 78-14, independents support 63-29, but Republicans oppose 28-56.

- Region: Eastern shore is split 49-39, Border is split 51-37. Broad approval in other regions.
- Age: Younger voters support by net 51 points, older voters only support by net 19 points.
- Race: Black voters support at higher levels than
 white voters.
- Education/Gender: Lowest support among noncollege men



Overwhelming support for pesticide-related policies

Now switching topics slightly, I'm going to read you some policies related to pesticide use in Maryland. For each, please indicate whether you support or oppose that policy.

Requiring that any mosquito pesticide sprayed in Maryland must be tested for P-F-A-S, sometimes called 'forever chemicals', to ensure they are P-F-A-S-free.
